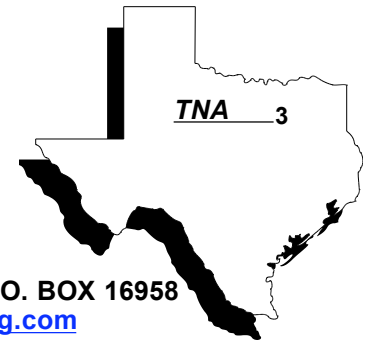

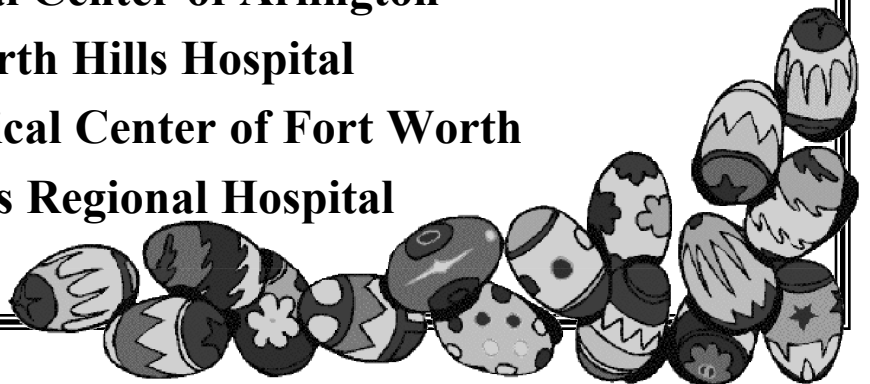

## Update from TNA's Governmental Affairs Committee

The Legislative Session is off and racing! Texas Nurses Association in collaboration with the Nursing Legislative Agenda Coalition met again January 22, 2005 to finalize its priorities for the already commenced legislative session. While the some twenty participating organizations do not agree on all the nursing issues and priorities, there are certain common concerns and issues on which general consensus has been achieved.

Here are a few highlights of the major nursing agenda priorities:

1. Texas Nurses Association is sponsoring some "cleanup language" to definitions for Vocational Nursing and Professional Nursing. Language between all the stakeholders is still being negotiated, so I am unable to provide details at this time.
2. Most of the Nursing Legislative Agenda Coalition (NLAC) are in support of a \$12 license renewal increase in order to support increased appropriations for the Peer Assistance Program, Criminal Background Checks and increase the Executive Director of the BNE's salary.
3. Texas Nurses Association will also be monitoring any changes in legislative bills which would allow anyone other than RNFA's ( RN First Assistants) or appropriately recognized APN's to assist with surgery in the OR.
4. Texas Nurses Association is actively seeking additional nursing shortage funding particularly as it relates to retaining and recruiting nursing faculty.

Other Legislation being monitored includes the possible interest of Paramedics and / or EMT's being given special consideration when applying for entrance into an ADN nursing program.

### **Coming March 1 and 2, 2005.....Nurse Day at the Capitol**

Capacity has been reached! All those who have already registered to attend this exciting day with the Legislature will be able to update those who can't go. The response of our legislators to nursing issues and concerns will be discussed during this two day interface with our Tarrant County delegation as well as all the nurses representing the state's various nursing districts. 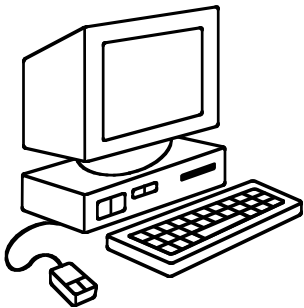

# “Safe Delegation, Safe Patients, Safe License”

In today's health care environment, most Registered Nurses in the state of Texas will work with Unlicensed Assistive Personnel (aides, PCTs, etc.). Failure to comply with the delegation rules of the Board of Nurse Examiners (BNE) is a reason that some Registered Nurses receive disciplinary sanctions on their licenses by the BNE. It is the responsibility of every licensed RN to know the Delegation Rules. If the RN has followed the BNE's delegation Rules, then, the RN will be able to put forward a defense, if the necessity arises due to harm caused by the actions of a UAP in carrying out a delegated task. Delegation in the practice of professional nursing is very specifically defined by the BNE as authorizing an unlicensed person to provide nursing services while the RN retains the accountability for how the task is performed. The Delegation Rule has been one of the most frequently reworded rules in the recent past. In the most recent revision, effective February 19, 2003, Delegation Rule 218 was replaced with two separate delegation rules: **Rule 224 Delegation of Nursing Tasks by Registered Professional Nurses to Unlicensed Personnel for Clients with Acute Conditions or in Acute Care Environments** and **Rule 225 Delegation to Unlicensed Personnel and Tasks not Requiring Delegation in Independent Living Environments for Clients with Stable and Predictable Conditions**. Though Texas now has one Board of Nurse Examiners, for RNs and LVNs, the Delegation Rules continue to be applicable only to Registered Nurses delegating to Unlicensed Assistive Personnel (UAP), and are not extended to Licensed Vocational Nurses. Both of the Rules are extensive and must be studied by the individual RN, in order to assure that she/he has an understanding of which rule applies in the individual's practice site and/or with the specific client. Rule 224 is most like the prior Delegation Rule 218, while Rule 225 is substantially different.

Rule 225 incorporates the concepts of activities of daily living, health maintenance activities and a client's responsible adult. If Rule 225 is to apply, in addition to being in an independent living environment, the client, or the client's responsible adult must be willing and able to participate in decisions about the client's health care management and the delegated task must be for a stable and predictable condition. If the less restrictive Rule 225 is not applicable, and this applicability can change with an individual client's status, then Rule 224 applies. Rule 224 is applicable for many RNs, as this is the Rule for delegation in acute care facilities.

Within Rule 224 is the concept that the RN must assess the client's status, the adequacy of the UAP and the task to be delegated, in making the decision to delegate a particular task to a particular patient at a particular time to a UAP. Depending on the client's status, what was appropriate to delegate one day, may

not be appropriate the next. Also within Rule 224 is the concept of categorizing of tasks. There are tasks which are most commonly delegated (i.e. vital signs, ambulating, feeding), discretionary tasks (i.e. sterile procedures, invasive procedures) and nursing tasks prohibited from delegation (i.e. formulation of a nursing care plan, responsibility for client health teaching). One of the most important concepts in Rule 224 is that of Supervision. After a decision to delegate is made by the RN, supervision must be provided. (Note: if a UAP is assisting an RN in the RN's presence, this is not delegation). Rule 224 lists specific requirements for the degree of supervision necessary for the RN to be in compliance with the Rule, and thus, able to defend her/himself if the UAP does not perform the task competently. Frequently, if an RN has to defend her/his practice as a result of a complaint before the BNE, it is the supervision component of delegation that is at issue. In a recent case, a nurse was disciplined by the BNE, not for the decision to delegate the task, which was for vital signs-one of the most commonly delegated tasks-but for the failure to provide adequate supervision in timely ascertaining the data. Therefore, the delegation may be deemed appropriate, but the ensuing supervision may be deficient. It is therefore incumbent on the RN to understand this element of the delegation process. Another important aspect of Rule 224 is the explicit inclusion in the definition of a UAP of the professional nursing student. If the professional nursing student is working at the practice site and is not there as part of the educational program, then that student is a UAP and the RN has to delegate to the student as she/he would to a UAP, regardless of the glorified title that a facility may have for a nursing student working as a UAP.

The BNE website ([www.bne.state.tx.us](http://www.bne.state.tx.us)) has not only the full text of Rule 224 and Rule 225, but also a "delegation packet" that includes Frequently Asked Questions, Links to Delegation Resources, Rule 224 Flowchart and Rule 225 Flowchart. These materials can assist the RN to become knowledgeable as to the delegation rules. With the knowledge, a greater level of confidence in working with an unlicensed person is possible, such that the RN does not feel her/his license is as vulnerable to the mistakes of others.
