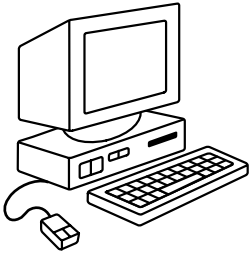
Monika Dewar Memorial Scholarship

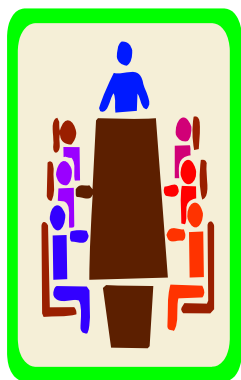

2007 House of Delegates Report

The 2007 Texas Nurses Association House of Delegates was called into session at 9:00AM on Saturday, April 21 in Austin, Texas. The HOD was preceded by a gala event on Friday night with a wonderful dinner and nostalgic walk down memory lane presented by nine of the state's past presidents dating back to the 1960's. A pictorial history of TNA's first 100 years reminded us as delegates of the role we would play, however great or small, the next day at the House of Delegates in furthering the profession of nursing.

When the House was called into session, the business was conducted by our outgoing president, Kathy Light. There were six resolutions before the House and all passed. Only one resolution, Mandatory Influenza Vaccination for Healthcare Workers, generated some lively discussion and an amendment around the word "mandatory". The amendment failed and the resolution was accepted as originally written with a few dissenting votes. A touching moment of silence was observed in honor of our military nurses and in memory of those nurses who have passed away. Although there is a courtesy resolution every HOD in memory of TNA members that have passed away, the resolution to honor our military nurses was new and received a unanimous vote.

I wish each member of TNA could experience House of Delegates because it is there that they would see what TNA is all about. It is about the business of the profession of Nursing and making the practice of Nursing what it is today and into the future. There is something very special about being a part of the House of Delegates and it was an honor to represent the district.

.....from the Governmental Affairs Committee

As many nurses call in their vote to American Idol and Dancing with the Stars, how many nurses in Texas are calling their local representatives to voice their opinions regarding their own profession?

The following excerpt from the TNA website to help explain what the GAC means to Texas and nurses:

The Texas Nurses Association's governmental affairs program (GAC) is based on a belief that nursing provides a unique and significant perspective when health policy decisions are made. Sharing that perspective in legislative and regulatory arenas has over the years created positive change for nursing and maintained quality health care for Texans.

It was members of TNA who initiated in 1909 the first nursing licensing act in Texas. Titled the Nurse Registration Act, it began a rich tradition of legislative involvement for TNA. Ever since, TNA has been active and vigilant at the Texas Legislature, advocating for its members, the nursing profession, and consumers of health care to assure a desirable practice environment for nurses and quality nursing care for Texans. Over the years experience has proven that if nursing fails to be involved, the important decisions for nursing and health care will be made by others less knowledgeable.

Many issues are being addressed, presented and voted on as I write this report. As a nurse in Texas it is your responsibility to be aware of Bills that are being discussed and voted on. These Bills may have either a direct or an indirect effect on your practice; however as a professional, it is important that you understand all areas covered. We urge you to take a few minutes and review all proposed bills.

Here are some highlights:

House Bill 1362 Relates to reports by nurses of certain conduct and protection from retaliation for those nurses. This Bill was *introduced* and *referred* to Committee on House Public Health 02/19/07.

Remarks: Clarifies the protections and remedies available to nurses (both RNs and LVNs) when they advocate for their patients or raise patient care concerns. This bill is jointly authored by the two nurses in the Texas Legislature – Rep. Donna Howard (D-Austin and former RN) and Rep. Susan King (R-Abilene and practicing RN). The legislation was initiated at the request of the Texas Nurses Association and came out of the work of one of its task forces looking at cultures of safety issues.

House Bill 1707 was created by the California Nurse's Labor Union relating to the practice of nursing in Texas has been *introduced* and *referred* to committee on House Public Health on 02/28/07 .

Remarks: This bill is initiated by the California nurses labor union. The Texas Nurses Association opposes the bill because it 1) distorts the legislative achievements the Texas Nurses Association and other Texas nursing organizations have achieved for Texas nurses over the past 25 years; 2) devalues nursing as a profession by repealing any obligation of nurses to report nurses whose continued practice puts patients at risk; 3) fragments nursing by creating a class of nurses that are portrayed as deserving of special protections and privileges of which other nurses apparently are not as deserving; and 4) will not improve patient care for Texans and is likely to make Texas' critical nursing shortage more difficult to address.

House Bill 2158 relating to nurse peer review and the regulation of the practice of nursing was *referred* to the House Committee on Public Health on April 13, 2007.

Remarks: Companion bill is SB 993. This bill is one of two bills that the Texas Nurses Association has initiated this session addressing the nurse's practice environment. The other is HB 1362 / SB 761. HB 2158's purpose is to shift the regulation of nursing away from an individual-blame oriented model and toward a model that focuses more on addressing system inadequacies and remediation of the individual. The bill accomplishes this shift by modifying the mandatory reporting provisions of the Nursing Practice Act to help ensure that the nurses reported to the BNE are those nurses whose continued practice poses a risk of harm to patients and by encouraging greater sharing of information among the various committees that review patient care incidents. Current law is slanted toward the view that errors are primarily caused by "bad" individuals and when an error occurs, the individual who made the error needs to be identified and punished. This bill reflects the view that errors are primarily the result of system inadequacies that either made the error likely to occur or failed to provide the safeguards needed to prevent the error from occurring.

House Bill 2426 Bill relating to the continuation and functions of the Board of Nurse Examiners *Passed* on 4/19/07.

Remarks:

Same as SB 907. BNE Sunset bill. Implements recommendations of Sunset Commission including recommendations of concern to nursing. Bill provisions of special concern are 1) reducing role of BNE in approving nursing education programs and 2) changing nursing peer assistance from an alternate reporting to a diversion program.

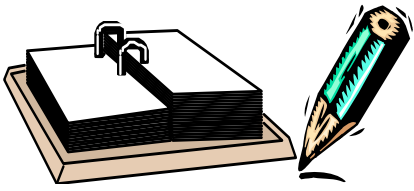
